SIBIU / Sibiu (LRSB)

1. Landing Charge

UNIT RATE: 6.30 EURO / tone

For airlines that perform irregular flights, the landing charge is supplemented as follows:

MTOW	Supplements
≤ 30 T	150%
31 - 59 T	120%
≥ 60 T	90%

The supplement does not apply to irregular flights operated by the airlines with which Sibiu International Airport R.A. has concluded a contract and performs regular flights according to a predetermined schedule.

2. Lighting charge

UNIT RATE: 1.50 EURO / tone / each movement using the lighting system

For airlines that perform irregular flights, the lighting charge is supplemented as follows:

MTOW	Supplements
≤ 5 T	Minimal CHARGE = 15 EURO
6 - 30 T	CHARGE + 100%
≥ 31 T	CHARGE + 75%

The supplement does not apply to irregular flights operated by the airlines with which Sibiu International Airport R.A. has concluded a contract and performs regular flights according to a predetermined schedule.

3. Parking charge

UNIT RATE: 0.05 EURO / tone / hour

For airlines that perform irregular flights, the parking charge is supplemented as follows:

≤ 20 T	500% but not less than 2.50 euro/h	300% but not less than 1.50 euro/h

≥ 41 T	300% but not less than 7.50 euro/h	200% but not less than 4.50 euro/h

The supplement does not apply to irregular flights operated by the airlines with which Sibiu International Airport R.A. has concluded a contract and performs regular flights according to a predetermined schedule.

4. Passengers service

UNIT RATE: 2.50 EURO / passenger

For airlines that perform irregular flights, the passenger service charge is supplemented as follows:

Passengers number	Supplements
≤ 10	300%
11 - 20	250%
21 - 40	150%
≥ 71	100%

The supplement does not apply to irregular flights operated by the airlines with which Sibiu International Airport R.A. has concluded a contract and performs regular flights according to a predetermined schedule.

SECURITY CHARGE: 1.00 EURO / passenger TRANSIT OR TRANSFER: 1.00 EURO / passenger

5. Other charges

6. Exemptions

- I) The airport users that consider they should be exempted from VAT, should provide to the airport administration 24 hours before the start of the flight the following documents:
 - VAT number in accordance with company's Certificate of Registration as a tax payer for VAT;
 - a copy of the Air Operator Certificate (AOC).
 - II) Parking charge: The parking charge is not applied for the first 3 hours after landing.

7. Reductions

7.1 The rebates applied to the landing charge are determined by the number of landings performed by one air operator in one month, as follow

Number of landings / month	Landing charge rebate (%)

57 - 64	35
65 - 72	40
73 - 80	45
81 -	50

Note: Rebates are granted according to an agreement concluded between airport administration and air operator.

7.2 Incentive schemes

Sibiu International Airport has developed a Commercial Policy based on the Market Economy Investor Principle which aims both to stimulate traffic growth and give the passengers a better choice of destinations and flights. General conditions

- The following incentive schemes are granted on a transparent and nondiscriminatory basis to all airlines interested in, on the basis of the eligibility criteria for each individual scheme.
- The following incentive schemes cannot be cumulated.
- Airlines benefiting from an incentive scheme cannot choose to change it during the period of valability. It thus makes available to all interested airlines 4 (four) types of incentive schemes, as follows:
 - 1. Incentive scheme for opening new routes
 - 2. Incentive scheme for the reopening of suspended routes
 - 3. Incentive scheme for passenger traffic growth
 - 4. Incentive scheme for the opening of new seasonal routes

8. Methods of payment

- 8.1 The payment of the charges in the above items 1 5 is levied in LEI for Romanian air operators and in EUR for foreign air operators.
- 8.2 The payment of airport charges, for aircraft carrying out non-scheduled flights, will be effected in cash or by card (VISA or EUROCARD/MASTERCARD) to the airport handling operator / ATC.
 - 8.3 Charges do not include the legal VAT rate.
